03. Subject to condition of providing school location, area, building, furniture, Teaching aids, staff, financial benefits etc.
04. The issue of registration is verified by Government Order No. ED.14:SES.98, Dated 17-03-99, to register the institute Kanachur Primary School, Deralakatte to open. This is in accordance to the report by the school Inspection Officer of this office, the location where the institution intends to open the school \_\_\_\_\_ number of \_\_\_\_\_ Government Primary Schools \_\_\_\_\_ numbers of unaided private elementary schools are now in existence within 2 km vicinity and also it is understood that these schools serve the educational needs of the location. However, the Supreme Court upheld the constitutional right of free education for children under the age of 14 in the Unni Krishnan case. According to the constitutional Right for free and compulsory Primary Education is the responsibility of the State Government can be provided by the private institution and self motivated institution. To meet the educational needs of the children of parents who do not want to send their children to government or aided schools even though there is no need for another primary school in this location and Since it aims to give parents and children greater freedom of choice as well as the school has been registered on a permanent non-grant basis to open another school in the self-motivated reporting area.

05. The institution cannot, in any case, open more sections without the government's prior approval.
06. The school shall be opened only in the sanctioned medium and the same place and in any case, is not allowed to change the location.
07. The governing body is allowed to run the school in the same place and the school should be run under the same name and also for no reason is there any chance of handing over without the prior permission of the government.
08. As per Govt. Order No. ED: 29/04-94 some schools using the Kannada or children's mother tongue as the language for medium of instruction from 1st to 4th grade, the language policy has been registered for the 5th grade to English medium. Violation of the language policy in schools registered under the language policy clause, Government Department: Registration for the school will be canceled as per rules of Kannada Development Authority.
09. Medical examination of students should be conducted every year.
10. Karnataka Comprehensive Education Bill 1983 Karnataka Act 1995 Act and in accordance with the rules created and approved and strictly adheres to all the conditions and orders issued by the authorities.
11. All registered schools for the schools run by the educational institution as per Government Notification ED 175: PMC 95, Dated 07-09-98 and Government Notification No. ED. 175:PMC97, Dated 29-12-98 are considered permanently unaided schools.
12. As per Karnataka Private Educational Institutions (Discipline and Regulation) Rules 1978 the rules must be followed.
13. Applications must be made to the District Deputy Director through the Block Education Officer for the first accreditation within 2 months of the commencement of the school.
14. The ratio of children and teachers in each approved class shall be governed by the rules.
15. Only trained and qualified teachers shall be appointed as per departmental rules.
16. All schools registered under section 6 subsections 36 to 39 of the Karnataka Education Bill may be covered under Recognition and Provisional Recognition.
17. In order to start the school, the institution should deposit the security deposit in the joint account of the Deputy Directors and Secretaries of the Administrative Board.
18. As per the rules of the Karnataka Education Act necessary amenities school furniture, study materials, Library, Play Ground, and School Building such as these should be provided within a year. Otherwise the registration will be cancelled.
19. About school openings and student registrations details to be submitted to the Block Education Officer within 2 months of the commencement of the academic year. This Recognition is canceled in case the school fail to open or failed to follow the conditions, rules and regulations.
